CALL MEETING TO ORDER.

Meeting called to order at 6:32 PM by Chairperson Tom Stifter.

ADOPT AGENDA.

A motion to approve the agenda was made by Council Liaison McNeilly and seconded by Commissioner Sommerfeld. Motion carried 5/0.

APPROVAL OF MINUTES.

A motion to approve the April 11, 2024 Planning Commission minutes was made by Council Liaison McNeilly and seconded by Commissioner Strand with the amendment to correct Council Liaison McNeilly's last name throughout. Motion carried 5/0.

PUBLIC HEARING – REZONE OF 221, 301, 305 ASH AVENUE SOUTH AND ADJACENT OUTLOT PROPERTIES FROM C/I COMMERCIAL/INDUSTRIAL DISTRICT TO R-1 LOW DENSITY DISTRICT.

At 6:33 PM Chairperson Stifter opened the public hearing.

City Administrator Johnson presented the information for the rezone to the Planning Commission.

Ryan Kusske asked about the differentiation between the City's zoning classification and the County's taxation classification.

Commissioner Sommerfeld inquired if the other adjacent property owners were contacted regarding the rezone.

City Administrator Johnson responded that they had received notice of the public hearing.

Commissioner Hahn asked about the need for the deed restriction on the property.

City Administrator Johnson discussed how the deed restriction would expedite the process whereas a replatting to combing the parcels would take months to complete.

A motion was made by Council Liaison McNeilly and seconded by Commissioner Sommerfeld to approve the rezone request conditioned upon execution of the deed restriction. Motion carried 5/0.
